

Perm Forum: General Sponsorship Package

Congress-business opportunities:

General provisions:

- Advance accreditation of Sponsor representatives;
- Issuance of two (2) transit passes allowing Sponsor vehicles (whether privately-owned or leased) to enter the Forum site;

- Participation by the “First Person” of the Sponsor’s company in the VIP events held under the Forum’s Cultural Program (by advance agreement);
- Presentation of a Certificate of Forum Participation.
